

## Privacy Policy

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information. This information is correct at 21 April 2012.

### 1 What information do we collect?

We may collect, store and use the following kinds of personal information:

- (a) information about your computer and about your visits to and use of this website (including your IP address, geographical location, browser type and version, operating system, referral source, length of visit, page views, website navigation);
- (b) information relating to any transactions carried out between you and us on or in relation to this website, including information relating to any purchases you make of our goods or services;
- (c) information that you provide to us for the purpose of registering with us;
- (d) information that you provide to us for the purpose of subscribing to our website services, email notifications and/or newsletters;
- (e) information that you provide to us in order to make an enquiry about our services;
- (f) any other information that you choose to send to us.

### 2 Cookies

A cookie consists of a piece of text sent by a web server to a web browser, and stored by the browser. The information is then sent back to the server each time the browser requests a page from the server. This enables the web server to identify and track the web browser.

We use "session" cookies on the website. We use the session cookies to keep track of you whilst you navigate the website. Our use of session cookies is anonymous and used for analysing web traffic statistics—the information we store in these cookies is as described in section (1)(a). Our session cookies are served from [www.kosibah.co.uk](http://www.kosibah.co.uk) (the main site) and [www.yemio.co.uk](http://www.yemio.co.uk) (which is where we store the site images).

We do not use persistent cookies.

We use Facebook for user generated content (such as comments). Facebook may send you cookies to enable you to log into your Facebook account and post comments about our website.

Blocking all cookies will, however, have a negative impact upon the usability of many websites.

Our site continues to provide core functionality if you choose to block all cookies.

## 3 Using your personal information

Personal information submitted to us via this website will be used for the purposes specified in this privacy policy or in relevant parts of the website.

We may use your personal information to:

- (a) administer the website;
- (b) improve your browsing experience by personalising the website;
- (c) enable your use of the services available on the website;
- (d) send to you goods purchased via the website, and supply to you services purchased via the website;
- (e) send statements and invoices to you, and collect payments from you;
- (f) send you general (non-marketing) commercial communications;
